

## **THUNDER LAKE ASSOCIATION SPORTSMAN'S CLUB ASSUMPTION OF RISK AGREEMENT and WAIVER OF RELEASE**

The undersigned do hereby acknowledge and appreciate the **dangers and risks** associated with being present as a spectator, a participant or otherwise at the Thunder Lake Association Sportsman's Club (henceforth may be called TLASC), firing range and/or facilities at which, but not limited to, firearms, associative devices and/or weapons may or will be discharged/fired/shot/thrown, etc.

The undersigned do also fully understand, acknowledges and appreciates the potential property damage and risks at TLASC its range, facilities, etc.

**Assumption Of Risk:** The undersigned hereby freely recognizes and assumes full responsibility for the risk of damage or injury that may occur to the undersigned and his/her property while acting as a participant, and/or as an assistant and/or while as a spectator at the TLASC firing range or facilities.

**Waiver Of Release:** In consideration of participating, being present as a spectator or as a participant, the undersigned hereby releases and discharges the TLASC and/or the Thunder Lake Association, a Minnesota corporation, (henceforth called Association), from claims, demands, rights of cause of action, *whether known, anticipated, or unanticipated and resulting from or arising out of, or incident to, the undersigned's use of the firing range facilities*, either directly or indirectly. This release is conditioned upon the facilities and the property owned, leased, or used by the TLASC and the aforementioned property being constructed and maintained in a reasonable and commercially, safe condition for the participants, spectators, etc.

This instrument shall remain in full force and effective and will remain on file for the duration of paid membership to TLA and TLASC beginning on January 1<sup>st</sup>, \_\_\_\_\_. If someone formally leaves the Association, they also leave the TLASC and all rights to use the facilities immediately cease as does this Waiver of Release.

**WHEREAS**, in return for use of TLASC premises, facilities, etc. and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned acknowledges and consents to the following:

The undersigned hereby expressly agrees to not bring or provide any non-members access to the range, unless approval has been given prior to bringing a non-member, by a member of the Association Board and/or a TLASC Range Member (218-566-3000) and that the non-member will use only EPA approved ammunition, assumes the risk of entering the premises and of taking part in all activities on the premises, which include, but are not limited to, the discharge of firearms and the firing of live ammunition and associative devices or weapons.

The undersigned furthermore hereby acknowledges and agrees that he/she has received their state or federal approved gun safety permit and has received qualified training in firearm safety and further agrees to abide by the current ranges operational rules in effect that are published by the Association and TLASC and publically posted at the range for the safety of all firing range and facility participants.

This instrument binds the Undersigned and his/her executors, member approved guests, administrators, assignees or heirs and the Association.

The undersigned understands that all children must be supervised, at all times, while at the firing range, and shall not be left attended or unattended at vehicles. All children must have their parents' signature on this release before they may participate in or be a spectator at this range. The parents expressly assume all liability and risk on behalf of their children and/or their guests.

The undersigned, state they are of legal age and do hereby *voluntarily* execute this document with such understanding and knowledge of firing range area and its dangerous activity and his/her assumption of risk while at the firing range and its associated facility(s).
